The institute invites Applications (on purely temporary/part-time basis) from accomplished Indian and Foreign Nationals for Adjunct/Visiting Faculty in various areas of specialization. Reputed academicians, scholars, industry practitioners, and other professionals, both serving and retired can send their expression of interest.

Currently, we are looking for accomplished professionals in the areas of Organizational Behaviour & Human Resource Management, Accounting and Finance, Economics and Public Policy, Marketing Management, Strategic Management, Decision Sciences, Operations and Supply Chain Management, Information Technology and Systems and Communication and Cross Cultural Management. In addition, the Institute will be pleased to receive applications in other sectoral areas like Art and Cultural Management, Tourism Management, Financial inclusion, Digital technology, entrepreneurship etc.

The key responsibilities would be to develop and teach curriculum in the respective areas of expertise besides conducting research and community engagement projects. Senior colleagues with experience of having served in IIMs are welcome to engage in the mentoring roles with faculty, students and the staff.

Adjunct/Visiting faculty are expected to add value and expertise to complement the existing knowledge pool of the Institute.

The candidates should have at least 10 years of relevant teaching and research experience. Initially the engagement will be for a period of 3 months to 1 year. The emoluments will be as per Institute's norms commensurate with the experience and qualifications of the candidate.

The number of candidates to be appointed may vary depending upon the requirement. The Institute reserves the right to reject any or all the applications without assigning any reason thereof.

Interested persons may send their CV indicating education, major professional accomplishments and list of publications/articles, with a cover letter to [directoroffice@iimsirmaur.ac.in]. Those who are currently in service with Central Government/State Governments/Universities/Autonomous Institutes shall be required

to route their applications through proper channel. Those who wish to be considered under deputation will also be required to route their application through proper channel with statement of NOC.

Note: If sufficient number of applications are received by January 31, 2018, these will be processed in the first phase. Applications received after January 31, 2018 shall be processed in next phases, as deemed appropriate by Institute on the basis of periodic requirement.
