“CORRIGENDUM-I”

Subject: Corrigendum to Tender No. IIMS/PUR/OTE/25/2022-23 dated 01.04.2023 for “Installation of German Hanger Tent, providing of other items and Catering Services for the Convocation 2023 Function at IIM Sirmaur, Paonta Sahib.

Based on the queries/discussion with the prospective bidders, the following are the changes in the tender:

- A. At the Page No. 19 in the “Standard Conditions of the Tender” the following lines are added:
- 1.1 The Selected Bidders for Part-A & Part-B have to carry out the work/services as per work order issued to them. In case, if the Bidder/Service Provider fails to carry out the work & supply the services as per the time stipulated in the work order or unable to provide any part of the Work/Services, a penalty of 5% of the total value of the work order issued will be imposed and deducted from the total bill payment to be made to the bidder’s/Service providers.
- 1.2 In case the Service Provider fails to carry out any of the activity/Service mentioned in the Work Order, the same will be done by the Institute, and the cost will be charged to the Service Provider.
- B. At Page No. 4, Part –A in the portion “Scope of Work” of the tender document, following Sr. No. 1, 7 & 9 may read as below:

- C. At Page No. 17 of the tender document in the "Note:" section **Point No. c** may be read as "In case, the pax increases **marginally** from the number mentioned above, the bidder should arrange & supply with the same rate per pax as mentioned in the Original tender document.

The bidders are requested to kindly read necessary changes as mentioned above while submitting their technical & financial bids, otherwise the bids shall not be considered and straight way rejected. All other terms & conditions in the original tender document shall remain unchanged.
