RESPONSIBILITES UNDER THE CONTRACT:

The ISP would be responsible for the following:

- To provide 100 Mbps internet connectivity (OFC) at Indian Institute of Management Sirmaur, Himachal Pradesh on yearly rental basis.
- Internet Router/Mux/Modems Port at ISP Gateway for required Bandwidth and 32 public IP addresses of ipv4 pool.
- Installation commissioning, configuring of the link and hardware/software up to IIM Sirmaur end.
- Maintenance support service (24 Hours and 7 days a week) for Bandwidth and equipment.
- ISP or authorised person from ISP will be required to sign Service Level Agreement.
- Either party may terminate the contract after giving three-month notice.
- In the event of non-commencement or unsatisfactory performance of the work contract, the IIM Sirmaur reserves the right to cancel the contract agreement or to withhold the payment. In such eventuality IIM Sirmaur further, reserves the right to get the work done from some other agencies and in such condition the cost of the work has to be borne by the tenderer to whom the order has been awarded/issued.
- The Tenderer must supply, install and configure whatever is required to ensure proper functioning of all the supplied hardware and software. Whether mentioned in the Tender or not and whether mentioned in this quotation or not in order to Guaranty the proper function of the delivered items and the services as required, it will be completely sole and full responsibility of the tenderer. All the supplied items are required to be integrated with existing network and system of the IIM Sirmaur by the tenderer.
- The Tenderer should be ready to meet the tender conditions with respect to all activity like supply, installation, commissioning, operation, functioning and testing of all the Wi-Fi access points and switches etc. The tenderer will also integrate them with the existing network and systems of the IIM Sirmaur.
- Tenderer shall be responsible for providing the licenses required for the function of all the delivered items.

Contract Period:

 The contract will be initially for a period of two year. Based on satisfactory performance, the contract may be extended maximum up to another two years on same terms and conditions with the approval of the Competent Authority.

Maintenance:

The tenderer will be responsible for the comprehensive maintenance for the entire contract period of two year. Contract period will start after the acceptance of installation & testing of complete connectivity.

- The Tenderer will do preventive maintenance once a quarter for the upkeep of the Systems running and submit the quarterly check report.
- The tenderer shall give warranty for all the supplied items (24 month onsite warranty), conforming to the specified design and there are no defects in the process of manufacturing, packaging, transportation, delivery, installation and the working of the supplied items so as to ensure best services as required under this tender.
- The schedule will have to be adhered strictly.
- 99.5% Uptime shall be calculated as (Total Time—Down Time) X 100 /Total Time quarterly basis.
- Deduction in payment will be made for downtime in the quarterly bills raised by the ISP.
- The response time for attending the faults will be four hours (maximum) after the same are reported to the tenderer.
- The tenderer will rectify the faults within 24 hours failing which; the tenderer will arrange temporary 100 Mbps RF replacements. The services shall be provided 24 hours & 7 days in a week.

Performance Security or Performance Bank Guarantee (PBG):-

The successful bidder(s), on whom order will be placed, has to submit a performance security of 10% of the total order value at the earliest before release of any payment. Performance security has to be submitted in the form of Bank Guarantee/Demand Draft/FDR from any Nationalized/Scheduled commercial Bank in favour of the Administrative Officer, IIM Sirmaur. Performance security should remain valid for a period of two months beyond the date of completion of all contractual obligations of the successful bidder(s). No interest will be payable by IIM, Sirmaur on the Performance Security deposited. In case the contractor fails to provide satisfactory service, the Performance Security submitted by the bidder(s) is liable to be forfeited. An undertaking to this effect is to be submitted.

Late Bids

Disqualification
