
## 1. About IIM Sirmaur

#### 2. Scope of Work

  - 2. As the quantity of work is indicate, therefore, work order will be issued on per sq. ft./per item/per piece basis.
- 3. EMD Deposit- An EMD of Rs. 10,000/- in favour of Indian Institute of Management Sirmaur is required to be submitted by the Bidder payable at Paonta Sahib, H.P. However, MSME/NSIC organizations are exempted from EMD deposit.

### 4. General Terms & Conditions

- a. The bidders should submit self-certified order copies of similar type of works executed.
- b. The quotation forms complete in all aspects along with all required documents should besubmitted in sealed envelope to the Office of SPO, IIM Sirmaur.
- c. In case two or more bids are found equal and lowest, the Bidder having highest turnover during last three years will be selected as successful bidder.
  - In case any bidder does not agree to take order then subsequently the next lowest bidder(s) will be given chance to execute the order provided they match the L-1 bidder.
- d. The works will be executed on work order basis.
- e. Institute reserves the right to reject any quotation or all quotation without prejudice, prior notice, or any explanation/justification and the Institute also reserves the right to increase or decrease the quantity of the item(s) as per requirement.
- f. If a quotation is submitted without mentioning explicit rate of each item, quotation will not be considered for further processing.
- g. Quotation(s), if not duly signed by the contractor or his legally authorized partner, if any, will be considered invalid.
- h. Security deposit @ 2% shall be submitted by the successful Bidder and same will be refunded after completion of the defect liability period, i.e., 6 months from the

- date of payment of final bill and confirmation of no defect. The date of work completion will be counted as the date of payment of final bill.
- i. 2% Income Tax and other applicable taxes such as GST etc. shall be deducted as per applicable Govt. rules.
- j. Payment will be made on completion of job in one time basis.
- k. In the financial bid, the price should be inclusive of all taxes and discounts if any.
- Bidder is required to submit quotation for both New work and dismantling work as per QUOTATION FORM-cum-FINANCIAL BID-I and QUOTATION FORM-cum-FINANCIAL BID-II. However, two different vendors may be selected for both New and Dismantling works.
- m. Work completion period: Within 30 days from the issue of the work order/date of agreement. A period of 03 days will be added to the allocated period for the completion of this work.
- n. Late work completion penalty: If work is not completed within the given time, penalty will be deducted as per institute norms. It will be implemented in verbatim with no excuse to be entertained for whatsoever be the reason.
- o. Any damage caused to the building shall have to be made good by contractor at no extra cost & without any delay.
- p. Site must be cleared and made neat and clean. Any waste material resulted out of the work execution must be disposed off to the specified location identified by institute. If not, 1% extra charges shall be deducted from the bill to dispose of the malba.
- q. Bidder is required to submit three years financial turnover for the FY 2018-19, 2019-20 and 2020-21 alongwith the tender documents.
- r. Duly completed tender document alongwith Quotation for, should be sealed in one envelope, which is superscribed with Name of work, Tender Reference No. & date submitted on or before the last date & time as mentioned above.
- s. The Bidder must not be blacklisted/banned/suspended or have a record of any service-related dispute with any organization in India or elsewhere. A declaration to this effect should be provided.
- t. IIM Sirmaur reserves the right to cancel the Tender at any stage without assigning any reason thereof.

# 8. Dispute Settlement And Appointment of Arbitrator

All dispute or differences whatsoever arising between the parties out of or relating to the work and the resulting agreement or the breach thereof that cannot be settled by good faith and negotiations between the parties within 60 days of the commencement of negotiation shall be settled by referring the dispute to The Director, IIM Sirmaur, who may either himself decide the dispute as Arbitrator or appoint some other person as arbitrator to adjudicate the same, who shall be unconnected with IIM Sirmaur. The proceedings will be governed by the provisions of the Arbitration & Conflation Act 1996.

By consent of parties the jurisdiction of all other courts are exculpated and the court at Paonta Sahib, H.P. alone shall have jurisdiction. The language of Arbitration shall be English. The venue of Arbitration proceedings shall be Paonta as the case may be.
